We may collect and process the following personal information:

Information you provide to us

When you contact us or use our website forms, we may collect:

- name
- email address
- phone number
- company or organisation name
- project details or enquiry information

Information collected automatically

When you visit our website, we may automatically collect certain technical information including:

- IP address
- browser type and version
- pages visited
- time and date of visits
- referring website

This information is typically collected using analytics tools and cookies.

4. How we use your information

We use personal information for the following purposes:

- responding to enquiries or requests
- providing information about our services
- communicating about projects or services requested
- providing services such as licence applications specifically requested by the client
- improving our website and services
- maintaining website security

We do **not sell or rent personal information to third parties**.

5. Lawful basis for processing

Under UK GDPR, we rely on the following lawful bases for processing personal data:

Legitimate interests

Consent

Where you provide consent, such as agreeing to the use of cookies.

Contract

Where processing is necessary to provide services requested by you.

6. Sharing your information

We may share personal data with trusted third party providers who support our business operations, such as:

- website hosting providers
- IT support services
- analytics providers

These providers only process personal data on our behalf and must comply with appropriate data protection obligations.

We may also disclose personal data where required by law.

7. Data retention

We retain personal data only for as long as necessary to fulfil the purposes for which it was collected, including for legal, accounting or reporting requirements.

Enquiry information is typically retained for a reasonable period to allow us to respond and manage potential business relationships.

8. Cookies

Our website uses cookies and similar technologies to improve functionality and analyse website usage.
